Mentioned below are research works conceptualised, designed and presently being carried out by me or in conjunction with academic colleagues.

#### 1. Development and Validation of Spiritual Abuse Index (SAI) February, 2016

This project intends to develop and validate a measure of Spiritual Abuse Index. Spiritual abuse is a relatively new term but its practice is probably as old as civilization. Spiritual abuse occurs when a person in the position of spiritual authority uses his or her position to control another person. It involves placing the needs of the person in authority over the needs of the person seeking help without regard to an individual's actual well-being. The fact that the concept is relatively new means that the counselling psychologists do not have adequate and standardised instruments on the concept for the purpose of counselling spiritually abused individuals in Nigeria. The research would be categorically descriptive in nature. The Spiritual Abuse Index (SAI) is a 35-item instrument. Two hundred workers would be randomly selected from Oyo State, Nigeria. The participants consist of male and female individuals whose ages range between 20 and 60 years old. They would cut across socio-cultural, religious, and educational backgrounds. Principal Components and Confirmatory Factor Analyses would be utilised to analyse data. The data would be purified by removing any item with less than 0.3. This instrument would be very useful for counselling and research purposes among counselling and clinical psychologists.

# 2. Prevalence, Purposes and Predictors of Social Networking Sites Utilisation among Some Selected Undergraduates in Nigeria. May, 2016

This study examines prevalence, purposes and predictors of socials networking sites utilisation among undergraduates. The variables of interest are age, gender, social economic status and internet efficacy. The main purpose of this study is to examine the prevalence and purpose of social networks (SNS) (facebook and whatsapp) utilisation among undergraduates. Specifically, the study will examine the prevalence use of facebook and whatsapp as a social networking sites, the purposes of the utilisation of facebook and whatsapp by the University of Ibadan undergraduates, determine the relative influence of age, gender, socio economic status and internet efficacy on social network utilisation and, find out the composite effects of age, gender, social economic status on social networking sites. The study will adopt a descriptive survey. The sample would be drawn from the undergraduate population across the six geo-political zones. Multistage sampling procedure would be used. This would include purposive and network sampling techniques. Percentage, Pearson product moment correlation, multiple regression

would be used as tools for analysis.

#### RESEARCH FOCUS

My research focus is discussed under three main groups namely:

- (i) Workplace resourcefulness
- (ii) Learners' motivation and achievement
- (iii) Holistic wellness.

I am keenly interested in workplace resourcefulness. As a result of this, I examined the role of spirituality, religion and moral education in the sustainability of development in Nigeria. My research works provided a strong link between spirituality and human performance at the workplace. From my research efforts, I have shown that several cognitive and non-cognitive factors are essential ingredients of job performance and satisfaction among workers. Furthermore, I engaged in the development of Yoruba version of emotional intelligence measuring tool for ease of use at work, family or recreational activities. My work strived to differentiate between religiosity and spirituality. While spirituality breeds meta-needs, religiosity breeds meta-pathologies. I concluded that Nigeria is highly religious but less spiritual which makes it impossible for her as a nation to achieve significant progress. My research recommended a strong mentoring process in the social order for Nigeria to achieve any significant sustainable development.

On learners' motivation and achievement, my research dwells on scholastic performance improvement among learners. Specifically, my research activities delved into determining predisposing psychosocial factors affecting learners' academic performance either at primary, secondary or tertiary institution levels. In summary, learners' behavioural disposition, temperament and environment are responsible for school adjustment and achievement. I have showcased the relevance and effectiveness of some new psychotherapies in boosting learners efforts in managing their education and career.

Another significant aspect of my research is holistic wellness. The role of counselling psychology in preventive and curative health management cannot be overemphasized. Therefore, several of my works revealed that gender, age, job tenure, social desirability, workplace social support, spirituality, social intelligence, educational qualification, emotional intelligence, resilience, self-efficacy and achievement motivation are very germane to effective management of stress and depression so as to achieve balanced holistic wellness. I have demonstrated through my research works that HIV/AIDS-related stigma is a barrier to caregivers' efforts to seek support. I noticed a strong need to enhance the orientation of the caregivers so as to improve the condition of the PLWAs. My study recommended awareness to the caregivers about epileptic disorder in order to reduce discriminating against those with epilepsy. I have also developed some treatment packages to manage maladjustment which ensue from psychological distress. These include dialectical behaviour, acceptance-commitment, existential, cognitive strategy instruction, cognitive restructuring, hopefocused and life-design therapies. Problems of poor social competence, self-esteem and employability problems could be remediated using these therapies. These studies provided evidence for social re-orientation among emerging adults.

On the whole, my contributions so far in the aforementioned areas have created more challenges to my intellectual inventiveness for more futuristic enhancement of human knowledge within the scholarship of Counselling Psychology as one of the major components of Education.
